- 1. Anyone less than 16 years of age must be actively supervised by an adult member while on this range.
- 2. Practice only on the site-in range, not on the targets throughout the course.
- 3.Do Not shoot broad head tips on any of the sight-in targets or targets on the course.
- 4.Do not backtrack on the course. This is a dangerous practice and is strictly forbidden.
- 5.A bow or a person must be in front of a target where someone is hunting arrows.
- 6.Range will be closed except on Sundays during hunting season so the property can be safely hunted. As hunting seasons change from year to year. The closed dates will be posted each year.
- 7.On Tuesdays between April 1 through September 15 the outdoor archery range will be closed for trap shooting.

INDOOR ARCHERY

- 1. Anyone less than 16 years of age must be actively supervised by an adult member while on this range.
- 2.If there are two (2) or more persons using the range a range officer shall be designated.
- 3.No board head tips may be shot at targets.
- 4. Only three (3) arrows per round.
- 5.All children must be supervised by an adult.
- 6.All persons must stay behind the shooting line until everyone is ready to retrieve arrows. Only after everyone is again behind.

RIFLE RANGE

- 1. Anyone less than 16 years of age must be actively supervised by an adult member while on the range.
- 2. Eye and ear protection shall be worn on this range.
- 3. Shotgun shells loaded with pellets will not be used on the rifle range.
- 4.If there are two (2) or more persons using the range, a range officer shall be designated.
- 5.Targets must be hung in a manner where all bullets enter the backstop and there is no damage to the target post and/or the cross members.
- 6. No shooting before 10 AM on a Sunday, 8 AM on other days.
- 7.No full automatic weapons on the range.
- 8. Paper targets only may be brought and used on the range by the member. Other targets such as spinning metal discs, may be used if such targets are approved by the Board of Directors.

SHOT GUN - PISTOL RANGE

- 8. Paper targets only may be brought and used on the range by the member. Other targets such as spinning metal discs, may be used if such targets are approved by the Board of Directors.
